Meanwhile, many autocratic leaders have successfully gauged the vulnerabilities of their opposition, allowing them to employ sophisticated methods of repression in both physical and digital realms. We will navigate the tools necessary to help activists identify threats, implement risk assessments, and develop comprehensive protocols for the security of their movement. The rise of mass surveillance also presents significant challenges for activists in their effort to maintain protection – not only through the means of physical and digital protection but also one’s mental well-being as they remain vigilant for their cause. With the rise of trauma caused by increased repression and disinformation, we aim to develop practices to prevent long-term psychological harm, while also reinforcing effective strategies to ensure one’s physical and digital safety.

As autocratic regimes worldwide extensively impose restrictive laws to curb dissent, activists must adapt to new challenges threatening their ability to organize and protest freely. One of the most pressing legislative threats is the enactment of foreign agent laws, which are used to censor activists and organizations who oppose the acting government's repression. We will examine the implications of these laws and discuss ways to navigate their restrictions. With the growing trend of banning protests and other forms of public opposition, we will also explore how activists can adapt their tactics to continue peacefully advocating for change, even in environments where traditional forms of protest are criminalized. Movements have been targeted within the digital sphere too, as legal restrictions have extended to activists' use of media in our increasingly online world. The effective use of digital tools to combat unjust censorship, therefore, is vital in maintaining the stability of your movement. Understanding how and why legislation targets the rights of activists will allow us to develop innovative approaches to achieve the freedoms necessary for sustaining nonviolent movements under repressive regimes.
